

House Rules

- Hangar has adopted a policy of zero-tolerance for illicit drugs. Possession and/or dealing of drugs is strictly prohibited at Hangar. If there is any indication of drug use and/or possession, the drugs will be confiscated and the offender, along with the drugs, will be handed over to the police.
- Hangar reserves the right to refuse/deny (further) access to visitors who are drunk and/or under the influence of drugs.
- Hangar has a minimum age requirement of 18 years and requires visitors to present a valid government-issued ID upon request.
- Visitors cannot re-enter Hangar events after leaving the festival site. Re-entry is only possible by paying an entrance fee again, subject to event capacity. Only original and undamaged tickets are considered valid, and visitors must have a valid ticket in their possession.
- Hangar events visitors are subject to pre-emptive searches.
- Possession of drugs, glass, plastic bottles, cans, umbrellas, fireworks, weapons, or any other prohibited dangerous items are strictly prohibited at Hangar events. Additionally, substances, food, alcoholic beverages, drinks, and animals are also not allowed on the festival grounds.
- Medicine is allowed only with a written prescription or by notifying Hangar in advance via info@thehangar.be.
- Smoking is only permitted outdoor or in designated area's where ashtrays are available for smokers. It is strictly forbidden to throw cigarettes on the floor or in any other non-designated place. Hangar reserves the right to exclude a visitor if he/she violates this rule.
- Hangar has a zero tolerance policy on verbal or physical abuse or aggressive behavior, whether it is used against Hangar staff or towards other visitors.
- Visitors of Hangar must be dressed appropriately. Offensive, provocative or indecent clothing is not allowed on the festival grounds.
- Without written consent of Hangar, it is prohibited to promote or sell any kind of service or product. This also goes for the close surroundings of the festival terrain. Possible costs of cleaning will be charged to the company or organization who's responsible.
- Hangar will automatically have the right to use all video or photo material made on the festival terrain, free and without notice.
- It is not allowed to make professional audio or video recordings without written permission from the organization.
- Access to the Hangar event space/grounds will be denied to visitors who do not comply with these house rules and Hangar's 'Terms and Conditions For Visitors' without the right to reimbursement of tickets, any service charges and/or other costs.
- Visiting Hangar events is at the visitor's own risk. Hangar takes no responsibility for any damages on any grounds whatsoever, which directly or indirectly arise out of acts or omissions of Hangar, persons in its service, other persons who are working at the festival, or third parties during or in connection with the stay at the festival, unless the damage is caused by intent or gross negligence by Hangar. Hangar's responsibility is always limited to the grand sum paid by its insurance in this event.
- Visitors are required to follow instructions, regulations, and/or directions of (security) staff of Hangar events at all times.
- Visitors are advised to wear earplugs; these will be available at the first aid and info point of Hangar events.
- When entering and leaving Hangar events, visitors shall not cause nuisance or damage to the neighborhood and neighboring nature.
- Glasses and/or cups (empty or filled) cannot be taken outside the Hangar premises.
- Hangar requests visitors to immediately inform security or staff in the event of an emergency.
- Hangar events staff will have the final decision in these cases and/or in matters not covered by these house rules.
- Visitors entering Hangar premises agree to have read and understood these house rules and agree to comply with and be bound by them. These house rules and the Terms and Conditions for Visitors are always available at www.thehangar.be.
